End-User License Agreement ("Agreement")

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this End-User License Agreement:

- **Agreement** means this End-User License Agreement that forms the entire agreement between You and the Company regarding the use of the Application.
- **Application** means the software program provided by the Company named BuiltWith Pro
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to BuiltWith Pty Ltd, L35, One International Towers, 100 Barangaroo Avenue, Sydney NSW 2000.

If we determine your usage is not for your own commercial use or are generated reports with a high frequency we may cancel and disable your account without warning. Please contact us first if you believe this might be the case. Creating many variations of super large reports for massive data export is prohibited.
